with interest thereon from maturity at the rate of 18 per centum per annum, to be paid: semi-annually

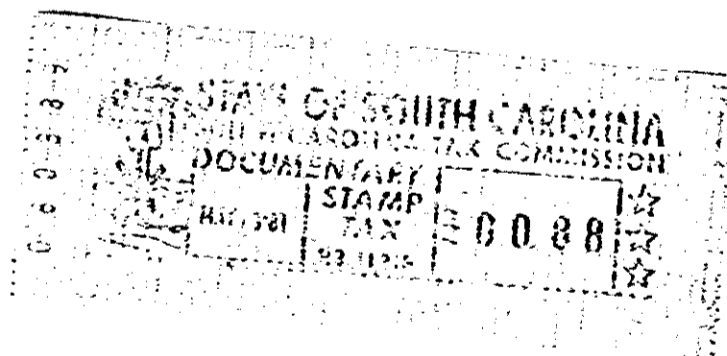

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near Greenville, in the County of Greenville, South Carolina, and being more particularly described as Lot No. 115, Section 1, as shown on plat entitled "Subdivision for Abney Mills, Brandon Platn, Greenville, South Carolina", made by Dalton & Neves, Engineers, Greenville, S. C., February 1959, and recorded in the Office of the R.M.C. for Greenville County in Plat Book QQ at page(s) 56 to 59. According to said plat the within described lot is also known as No. 13 Draper Street and fronts thereon 162.8 feet.

This is the same property conveyed to Doc T. Lindley and Virginia B. Lindley by Abney Mills on May 12, 1959, and recorded on June 1, 1959, in deed volume 624 at page 308 in the RMC Office for Greenville County, South Carolina.
