THIS MORTGAGE is made this 26th day of May 1981, between the Mortgagor, **Balentine Brothers Builders, Inc.**, (herein "Borrower"), and the Mortgagee, **UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF FOUNTAIN INN**, a corporation organized and existing under the laws of the United States of America, whose address is 201 Trade Street, Fountain Inn, S. C. 29644 (herein "Lender").

"NOTE" includes all Renewals and Amendments of the Note dated 26 May 1981. WHEREAS, Borrower is indebted to Lender in the principal sum of **Fifty-Five Thousand One Hundred and No/100 (\$55,100.00)** Dollars, which indebtedness is evidenced by Borrower's note dated 26 May 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on 1 September 2011

BEGINNING at an iron pin on the southerly side of Crowdale Court, joint front corner of Lots Nos. 150 and 151, and running thence S. 30-44 W. 161.70 feet to an iron pin in line of Lot No. 140; thence with line of Lots Nos. 140 and 141, N. 86-23 E. 218.34 feet to an iron pin at edge of branch; thence with the center of the branch, the traverse of which is, N. 8-12 W. 160.85 feet to an iron pin on the southerly side of Crowdale Court; thence with the southerly side of Crowdale Court, N. 87-24 W. 29.41 feet to an iron pin; thence with the radius of a 50 foot curve, the chord of which is N. 66-58 E. 90.15 feet to an iron pin, the point of BEGINNING.
