RENEGOTIABLE RATE MORTGAGE ASSUMPTION AGREEMENT

WHEREAS, American Federal Savings and Loan Association of Greenville, South Carolina, hereinafter referred to as the "ASSOCIATION," is the owner and holder of a renegotiable rate promissory note dated September 26, 1980, executed by Davidson Vaughn, a General Partnership; James W. Vaughn & N. Dean Davidson, as partners and individually; in the original sum of FIFTY ONE THOUSAND TWO HUNDRED FIFTY AND NO/100 (\$51,250.00) Dollars, bearing interest at the original rate of 10.875 per cent per annum and secured by a first renegotiable rate mortgage on the premises being known as Lot 1, Baldwin Circle, Mauldin, S.C., which is recorded in the RMC Office for Greenville County in Mortgage Book 1518, Page: 87, title to which property is now being transferred to the undersigned "OBLIGOR(S)," who has (have) agreed to assume said mortgage loan and to pay the balance due thereon; and

WHEREAS, the ASSOCIATION has agreed to said transfer of ownership of the mortgaged premises to the OBLIGOR and his assumption of the mortgage loan and all terms and conditions thereof.

NOW, THEREFORE, this agreement made and entered into this 27 day of May, 1981, by and between the ASSOCIATION, as mortgagee, and Robert A. Boyd and Lynn C. Boyd, as assuming OBLIGOR,

WITNESSETH:

In consideration of the premises and the further sum of \$1.00 paid by the ASSOCIATION to the OBLIGOR, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

1. That the loan balance at the time of this assumption is FIFTY ONE THOUSAND TWO HUNDRED FIFTY & NO/100 Dollars; that the interest rate at the time of the assumption is 10.875 per cent per annum and the monthly principal and interest installments are FOUR HUNDRED EIGHTY THREE AND 25/100 Dollars (US \$ 483.25), each with payments to be applied first to interest and then to remaining Principal, balance due from month to month with the first monthly payment due June 1, 1981; that the OBLIGOR agrees to repay said obligation on the terms and conditions set forth in the renegotiable rate promissory note, renegotiable rate mortgage and rider thereto and further agrees to be bound by all terms and conditions of said instruments as if his signature appeared thereon as the original borrower.
2. That the assuming OBLIGOR does hereby acknowledge receipt of a copy of the original renegotiable rate note, renegotiable rate mortgage and rider thereto which is being assumed by said OBLIGOR.
3. Should any installment payment become due for a period in excess of fifteen (15) days, the ASSOCIATION may collect a "late charge" not to exceed an amount equal to five per centum (5%) of any such past due installment payment.
4. That all terms and conditions as set out in the original renegotiable rate note, renegotiable rate mortgage and rider thereto shall continue in full force, except as modified expressly by this agreement.
5. That this agreement shall bind jointly and severally the successors and assigns of the ASSOCIATION and OBLIGOR, his heirs, successors and assigns.
