with interest thereon from date at the rate of -16.75- per centum per annum, to be paid:

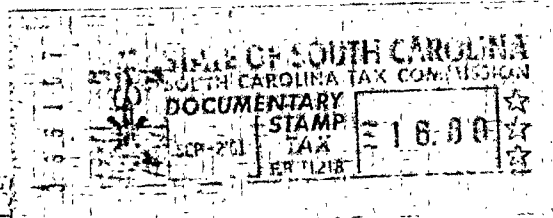

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 24 on plat of Map No. 2, Liberty Park, recorded in Plat Book MM at page 39 and having such courses and distances as will appear by reference to said plat.

This is the same property conveyed to the mortgagors by deed of Linda Elder Van Keuren Daily on even date by deed recorded in Deed Book 1154, Page 487, RMC Office for Greenville County.

At the option of the mortgagee, the indebtedness secured hereby shall become due and payable if the mortgagor shall convey the mortgaged premises or if the title thereto shall become vested in any other person or party for any other reason whatsoever.
