To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of **Greenville**

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina in the Town of Simpsonville being located at the northwesterly intersection of Agewood Drive and proposed 50 foot street and being known and designated as Lot #427 on plat of Westwood, Section 5, as shown by plat thereof recorded in Plat Book 4-X at Page 63 and having, according to plat entitled William M. Duncan and Linda L. Duncan prepared by J. L. Montgomery, III, R.L.S. #4552, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly edge of Agewood Drive at the joint front corner of Lots #427 and 428 and running thence along the westerly edge of Agewood Drive S 4-18 W. 61 feet to an old iron pin at the intersection of Agewood Drive and the 50 foot street; thence with the line of said intersection S 49-48 W. 35.4 feet to an old iron pin on the northerly edge of proposed 50 foot street; thence with the northerly edge of said street N 84-12 W. 115 feet to an old iron pin; thence N 4-48 E. 86 feet to an old iron pin at the joint rear corner of lots 427 and 428; thence with joint line of said lots S 85-12 E. 140 feet to the beginning corner.

I will pay all taxes, liens, assessments, obligations, encumbrances and any other charges against the real estate and maintain insurance on the real estate in your favor in a form and amount satisfactory to you. The amount you pay will be due and payable to you on demand, will bear interest at the highest lawful rate, will be an additional lien on the real estate and may be enforced and collected in the same manner as any other obligation secured by this mortgage.

If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default.
