(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

DOLLARS (\$ 16,884.00)

with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid:

in 84 monthly installments of \$ 201.00 each, the first of said payments being due November 5, 1981, and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18 % per annum.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near the Town

of Fountain Inn, being shown and designated as Lot Number 25 on plat entitled "Golden Strip Subdivision" recorded in Plat Book TT at Page 19 in the RMC Office for Greenville County, S.C. and fronting 80 feet along Wenck Circle and running back to a depth of 157.3 feet on one side, 189.4 feet on the opposite side and being 86.4 feet across the rear of the lot.

This is the same property conveyed to the Mortgagors by deed of MCC Financial Services, Inc. recorded April 17, 1979 in Deed Book 1100 at Page 645 of the RMC Office for Greenville County.
