(hereinafter referred to as Mortgagor) is well and truly indebted unto Earle R. Taylor, Sr.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty Thousand and No/100 - - - - - Dollars (\$20,000.00) due and payable

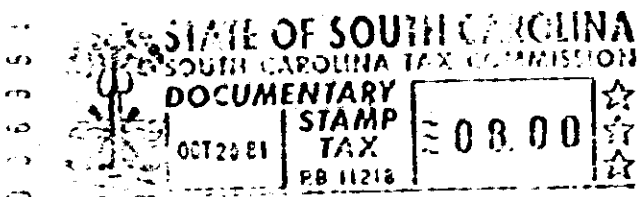
in 120 monthly installments of \$286.95 each beginning on November 16, 1981, and continuing until principal and interest have been paid in full. Said payments shall be applied first to interest, balance to principal. Mortgagors shall have privilege of prepayment without penalty. with interest thereon from date at the rate of 12% per centum per annum, to be paid monthly as aforesaid.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, being known and designated as Lots 13 and 14 on a plat entitled "Property of Ella Rector" prepared by H. S. Brockman, Surveyor, dated July 12, 1947, recorded in Plat Book T at Page 9 and being described in a more recent plat entitled "Property of Belmont Heights, Inc." prepared by John A. Simmons, Surveyor, dated November 9, 1960, recorded of even date herewith. The subject lots front on the northerly side of Tremont Avenue a total distance of 115 feet.

This is the identical property conveyed to the mortgagors by deed of mortgagee of even date herewith and this mortgage is given to secure a portion of the purchase price of the subject property.
