The mortgagor has the right to repay the entire amount of this mortgage at any time without penalty.

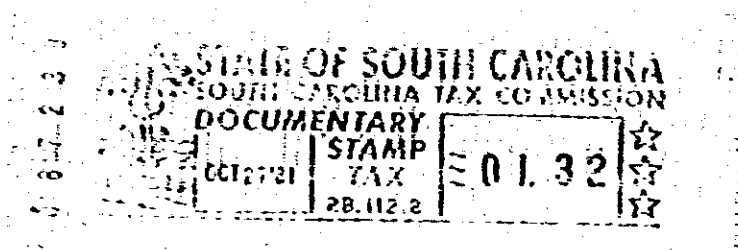
