Amount advanced: \$ 9658.47.

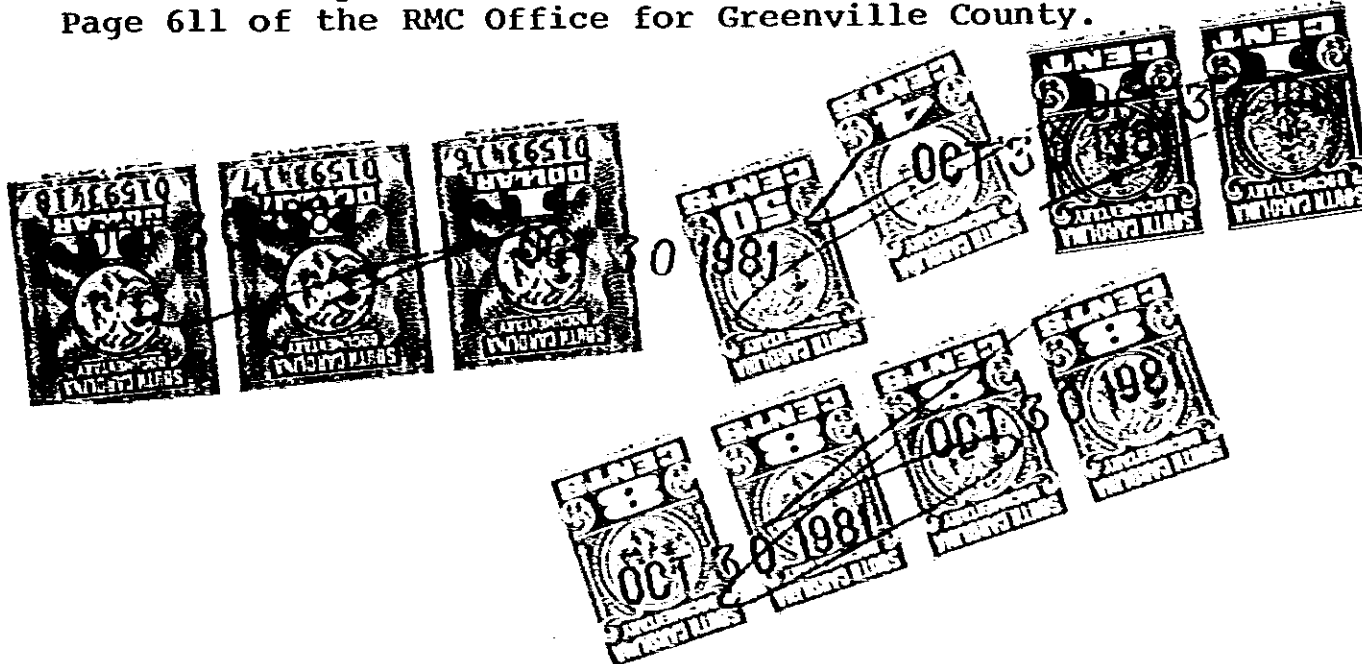
