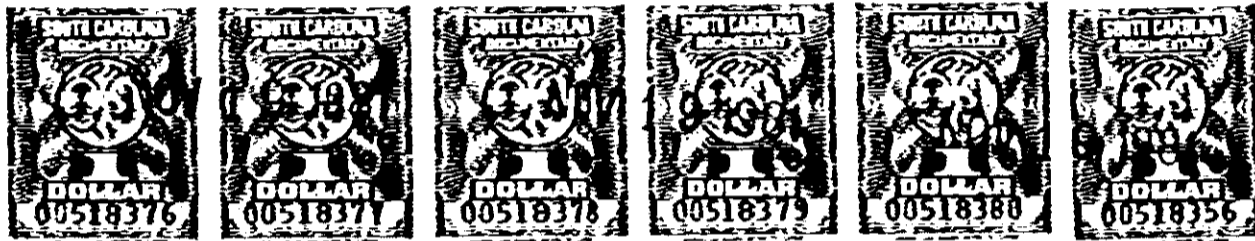

Description: All that certain piece parcel or lot of land, situate, lying and being
in the State of South Carolina, County of Greenville on the Southern side of
Lowndes Avenue, being shown and designated as lot no 27 on a plat of Elletson Acres,
section B, dated April 4, 1958, made by Clifford C. Jones and recorded in the RMC
Office for Greenville County, SC, in plat book QQ at page 5, and having according to
said plat, the following metes and bounds to wit:

Beginning at an iron pin on the southern side of Lowndes Avenue at the Joint front
corner of lots 27 and 28 and running thence with the southern side of said Ave., N.
05 E., 23.7 feet to a point; thence continuing with the southern side of said Ave., N.
05 E., 61.8 feet to a point at the joint line of said lots; thence, S. 55-55 E.,
152 feet to a point in creek; thence with the creek being the property line with the
traverse thereof being N. 24-32 E., 87.3 feet to a point; thence, N. 35-06 W., 167 feet
to an iron pin on the southern side of Lowndes Ave. to the point and place of beginning.
