SEND GREETINGS:

Whereas, I, we the said Clyde L. Wooten and Donna G. Wooten  
hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith,  
stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina,  
Greenville, S. C., hereinafter called Mortgagee, the sum of \$10,610.28  
plus interest as stated in the note or obligation, being due and payable in 84 equal  
monthly installments commencing on the last day of December, 1981, and on the  
same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. All that lot of land with the buildings and improvements thereon situate on the north side of Seminole Drive, near the Town of Simpsonville, Austin Township, Greenville County, SC, being shown as Lot No 47 on Plat of Section 1 of Westwood Subdivision, recorded in the RMC Office for Greenville County, SC in Plat Book 4-F at Page 21, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Seminole Drive at the joint corner of Lots Nos. 46 & 47 and runs thence along the line of Lot No. 46 N. 0-03 E. 150.85 ft. to an iron pin; thence along the line of Lot No. 45 S. 89-33 W. 100 feet to an iron pin; thence along the line of Lot No. 48 S. 0-06 W. 150 ft. to an iron pin on the north side of Seminole Drive; thence along Seminole Drive S. 89-56 E. 100 ft. to the beginning corner.
