"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on Babb Street, in the Town of Fountain Inn, fronting on Babb Street, 120 feet, more or less, with a depth of about 300 feet, bounded on the East by property now or formerly of C.A. Parsons, on the South by property now or formerly of M.M. Stevens, on the West by property now or formerly of C.E. Rogers and on the North by Babb Street.
