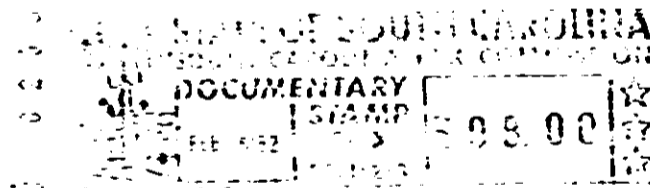
with interest thereon from date at the rate of $n/3$ per centum per annum, to be paid:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the town of Travelers Rest, containing 9.7 acres, more or less, according to a plat entitled, "Survey for Henry Prickett," by Williams and Plumblee, Inc., Engineering and Land Surveying, dated July 14, 1981, recorded in Plat Book 81 at Page 64 and having such metes and bounds as appear by reference to such plat.
