ALL that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, more particularly described as follows:

BEGINNING at a point at the western corner of property herein described and property heretofore released known as 3.41 acres and running thence along the southern side of Batesville Road, N. 72-47 W. 107 feet to a point; thence turning and running S. 40-23 W. 332.6 feet to a point; thence turning and continuing in a southwesterly direction and running to the rear corner of property now or formerly of J. W. Breazeale as shown on survey as containing one (1) acre, said distance being 350 feet; thence turning and running back along a joint line of property herein released and aforementioned property now or formerly of Breazeale, N. 34-46 E. 268.8 feet to an iron pin; thence turning and running along the joint line of Breazeale property, S. 34-18 E. 200 feet to an iron pin; thence continuing along the line of Breazeale property, S. 34-46 W. 200 feet to an iron pin; thence turning and running in a southeasterly direction to a point approximately 200 feet from the joint rear corner of the 3.41 acre tract heretofore mentioned and property to be encompassed by this Release, approximately 620 feet; thence turning and running N. 6-0 W. 200 feet to an ash tree; thence turning and running N. 61-21 W. 365.4 feet to a point; thence turning and running N. 15-42 E. 247 feet to a point; thence turning and running N. 7-35 W. 268 feet to the point of beginning.
