"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, on the Western side of Fountain Inn Drive in accordance with plat dated September 24, 1974 by Montgomery Surveying and Mapping Company and being more fully described, to-wit:

BEGINNING at an iron pin on the Western side of Fountain Inn Drive, joint front corner with lot in Bryson Acres Subdivision, and running thence N. 25-44 E., 200 feet to an iron pin; thence N. 63-13 W., 300 feet to an iron pin; thence S. 25-44 W., 200 feet to an iron pin; thence S. 63-13 E., 300 feet to an iron pin, being the point of beginning.
