



MORTGAGE

THIS MORTGAGE is made this 11th day of August 1982, between the Mortgagor, Steven Epps and Mary Lou Epps (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-six thousand, two hundred, eighty-six and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 11, 1982 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 1992;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel of lot of land situate, lying and being in the State of South Carolina, County of Greenville, in the corporate limits of Mauldin, being shown on plat of R. B. Bruce, R.L.S., as Lot No. 112 on a plat of FORRESTER WOODS, SECTION 7, recorded in the R.M.C. Office for Greenville county in Plat Book 5-P, pages 21 and 22, reference to said plat is hereby craved for the metes and bounds thereof.

This is that same property conveyed by deed of Charles D. Rankin and Marian O. Rankin to Steven Epps, Jr. and Mary Lou H. Epps, dated 6/4/81, recorded 6/19/81, in Deed Volume 1150, at Page 277, in the R.M.C. Office for Greenville County, SC.

which has the address of Rt. #10, 222 Stoney Creek Dr. Greenville SC 29607 (herein "Property Address");

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
