"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Emily Lane, being known and designated as Lot No. 5 as shown on a plat entitled ANNISSA ACRES made by C. C. Jones recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-R at Page 63 and having, according to a more recent survey thereof entitled PROPERTY OF RAYMOND P.
