Greenville County, South Carolina -----, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Charter Mortgage Company -----

-----, a corporation organized and existing under the laws of Florida -----, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eighteen Thousand Seven Hundred and No/100 ----- Dollars (\$ 18,700.00 -----).

ALL that piece, parcel or lot of land, with all buildings and improvements, lying on the southern side of Rutherford Road, in the City of Greenville, Greenville County, South Carolina being designated as Lot No. 14 on a plat of RUTHERFORD PARK, made by Dalton & Neves, Engineers, dated September 30, 1946, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book P at Page 109, reference to which plat is hereby craved for the metes and bounds thereof. Said lot being 45 feet wide and 122.37 feet deep.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
