"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Neely Ferry Road, being shown as a one acre tract of land on a plat of the Property of Nena Bell Garrett dated September 29, 1978, prepared by Freeland & Associates recorded in the RMC Office for Greenville County in Plat Book 6-Z at Page 75 and having, according to said plat, such metes and bounds as are more fully shown thereon.
