All that certain piece, parcel or tract of land, situate, lying and being in the State of South Carolina, County of Greenville, in the Glassy Mt. Township, on the southwest side of Jamison Mill Creek and being known as part of the N. E. Lockhart Estate and being more particularly described as follows:

BEGINNING at an iron pin at the corner of properties now or formerly owned by Toy A. Hyder, Jr., Stewart, and McCall and running thence North 64 degrees, 30 minutes West 1046.1 feet to an iron pin at the corner of the properties now or formerly owned by Gosnell and Lockhart and thence North 36 degrees, 00 minutes East 261.4 feet to an iron pin; thence to an iron pin at R. BEGINNING on a maple on the North side of Jamison's Creek and running North 14 degrees, 15 minutes East 130 feet to a stake; thence North 27 degrees, 00 minutes West 327 feet to a stake; South 63 degrees, 00 minutes West 30 feet more or less to the center of the branch; thence down the branch with the branch as a line to the intersection of the branch with Jamison's Creek; thence down the creek to a maple on the north side of the creek, the beginning point.
