THIS MORTGAGE is made this 25th day of October 19. 82, between the Mortgagor, Victoria Hannouche

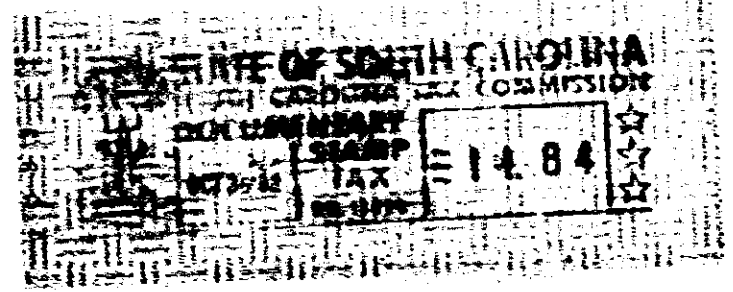
