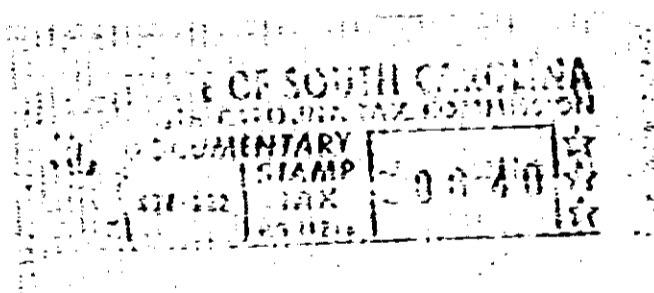
WITNESSETH:

IN CONSIDERATION of the sum of Three Dollars (\$3.00) paid to Mortgagor by Mortgagee and in order to secure the payment of a promissory note including any renewal, extension or modification thereof (hereinafter referred to as the "Note"), dated November 5, 1982, to Mortgagee for the principal amount of Sixteen Thousand and No/100 (\$16,000.00) Dollars, plus interest thereon and costs of collection, including attorneys' fees, and to further secure all future advances or re-advances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note or any renewal, extension or modification thereof or evidenced by any instrument given in substitution for said Note, Mortgagor has granted, bargained, sold and released to Mortgagee and the successors and assigns of Mortgagee, and by this Mortgage does grant, bargain, sell, and release to Mortgagee and the successors and assigns of Mortgagee, all the following real property (hereinafter referred to as the "Property"):

ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the northeastern corner of the intersection of Shallowford Road with Hialeah Road in the City of Greenville, County of Greenville, South Carolina being shown and designated as Lot No. A on a plat entitled "Revision of Lots 476 through 479, Section D, Gower Estates", made by R.K. Campbell & Webb Surveying and Mapping Company, dated September 24, 1964 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book HHH at Page 78, reference to said plat is hereby craved for the metes and bounds thereof.

The above property is the same property conveyed to the mortgagor by deed of Walter R. Payment and Barbara Z. Payment recorded November 7, 1977 in Deed Book 1067 at Page 998.

This mortgage secures a note of even date herewith executed and delivered by Priest Fuller to the mortgagee herein in the original sum of \$16,000.00.

Mortgagor further covenants to warrant and forever defend all and singular the Property unto Mortgagee and the heirs, successors or assigns of Mortgagee from and against Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

PROVIDED ALWAYS, nevertheless, and it is the true intent and meaning of Mortgagor and Mortgagee, that if Mortgagor pays or causes to be paid to Mortgagee the debt secured hereby, the estate hereby granted
