MORTGAGE OF REAL ESTATE

THIS MORTGAGE is made this 18th day of November, 19 82
between the Mortgagor Alexander C. Acree
(herein "Borrower"), and the Mortgagee, First Federal Savings & Loan Assn. of South Carolina,
a corporation organized and existing under the laws of The United States,
whose address is P. O. Drawer 408, Greenville, S. C. 29602
(herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$46,500.00 Dollars,
which indebtedness is evidenced by Borrower's Note date November 18, 1982 (herein "Note"),
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner
paid, due and payable on December 1, 19 2012.

TO SECURE to Lender: (a) the repayment of the indebtedness evidenced by the Note with interest thereon,
the payment of all other sums with interest thereon, advanced in accordance herewith to protect the security of
this Mortgage, and the performance of the covenants and agreements of Borrower herein contained; and (b) the
repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21
hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's
successors and assigns the following described property located in the County of Greenville,
State of South Carolina:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate,
lying and being near the City of Greenville, County of Greenville, State of South Carolina,
being known and designated as Lot 7, on plat of Property of Homer Styles and Ruth B. Mauldin,
which plat is recorded in the RMC Office for Greenville County in Book KK, page 104, and
having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Montis Drive (formerly Paris View Drive)
joint front corner lots 7 and 8; and running thence along Montis Drive (formerly Paris View
Drive) N 00-45 W 100 feet to an iron pin, joint front corner lots 6 and 7; thence S 89-15 E
150 feet to an iron pin, joint rear corner lots 6 and 7; thence S 00-45 E 100 feet to an iron
pin, joint rear corner lots 7 and 8; thence N 89-15 W 150 feet to an iron pin, the point of
beginning.

This being the same as that conveyed to Alexander C. Acree by deed of Fred Tiller being dated
and recorded concurrently herewith.
