"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as the greater portion of Lot No. 6 on a plat recorded in Plat Book 6M at Page 96 and also shown on a plat recorded in Plat Book 7Y at Page 98; being the property conveyed to the mortgagor by deed of Rick Fairbanks dated Sept. 25, 1978 and recorded in Deed Book 1088 at Page 506.
