MORTGAGE OF REAL ESTATE

R.M.C. TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Earl Singleton

(hereinafter referred to as Mortgagor) is well and truly indebted unto The City of Greenville, a municipal corporation, Post Office Box 2207, Greenville, South Carolina 29602

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand One Hundred Forty-Eight and 80/100-----

-----Dollars (\$ 3,148.80 ) due and payable  
in 120 consecutive monthly installments of \$26.24 each on the 15th day of each month commencing April 15, 1983.

with interest thereon from April 15, 1983 at the rate of 0% per centum per annum, to be paid: according to the terms of said note.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 19 of the Property of Ladson A. Mills, as shown by plat thereof prepared by Dalton & Neves, dated January, 1928, and recorded in the R.M.C. office for Greenville County in Plat Book H at page 117, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Lindberg Avenue, 179.3 feet from Gower Street, at the joint corner of Lots No. 19 and 20, and running thence with the west side of Lindberg Avenue, S 37-00 W, 46 feet to an iron pin at the joint front corner of Lots No. 18 and 19; thence with the line of Lot No. 18, N 53-00 W, 108.1 feet to an iron pin at the joint rear corner of Lots No. 18, 19, 27 and 26; thence with the rear line of Lots No. 26, N 40-15 E, 46.1 feet to an iron pin at the joint rear corner of Lots No. 19, 20, 25 and 26; thence with the line of Lot No. 20, S 53-00 E, 105.6 feet to an iron pin on the west side of Lindberg Avenue, the BEGINNING CORNER.

This property is known and designated as Block Book No. 76.2-2-7.

Being the same property conveyed to Earl Singleton by deed of George A. Weathers, recorded in the RMC Office for Greenville County in Deed Book 666 page 480, on January 19, 1961.

This mortgage is junior and subordinate to a mortgage executed by Earl Singleton to Reverend L. B. Moon, recorded in REM Book 847 page 475, on January 19, 1961.

FUTURE ADVANCES: As additional consideration, pursuant to Section 29-3-50 of the 1976 Code of Laws of South Carolina, this mortgage is given to cover, in addition to all existing indebtedness of Mortgagor to Mortgagee (including but not limited to the above-described advances) evidenced by promissory notes, and all renewal and extensions thereof, all future advances that may be made to Mortgagor by Mortgagee, to be evidenced by promissory notes, and all renewal and extensions thereof, the maximum principal amount of all existing indebtedness and future advances outstanding at any one time not to exceed \$3,500.00 plus interest thereon, attorneys' fees and court costs as provided herein."
