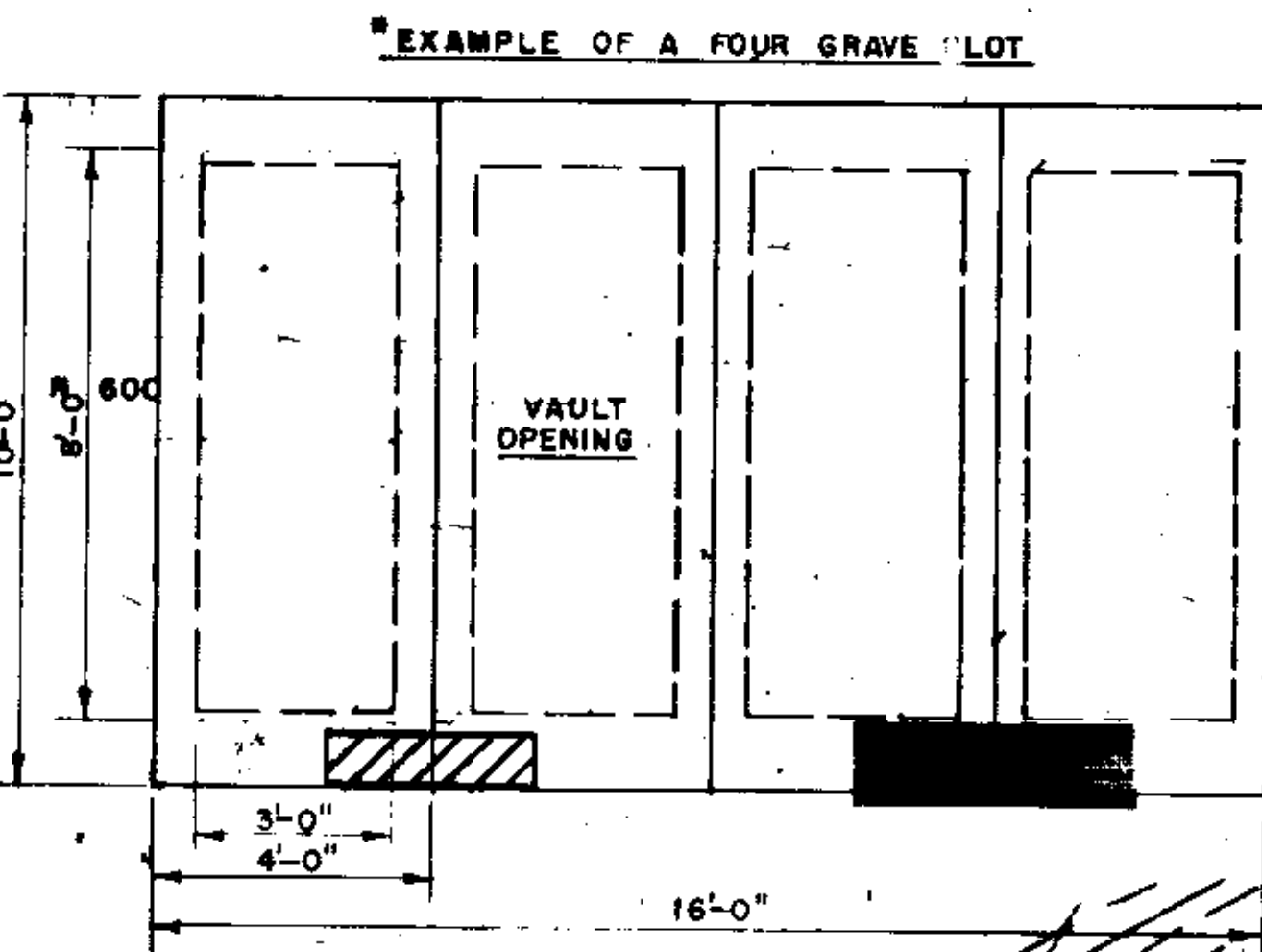

GENERAL NOTES

1. THE LOCATIONS OF ALL EXISTING GRAVESITES ARE APPROXIMATE.
2. TO FIND THE OWNERS OF EXISTING LOTS, SEE SHEET 1.
3. THE VARIOUS SECTIONS ARE ALPHABETICALLY DESIGNATED.
4. THE LOTS IN SECTIONS A AND B ARE NOMINALLY 20' X 20' (FRONT X SIDE) IN SIZE, WITH 4' X 10' AND 5' X 10' DIVISIONS.
5. SECTION C LOTS ARE MORE VARIABLE IN WIDTH AND LENGTH; LOT SIZES ARE RECORDED IN A SEPARATE BOOK.
6. LOTS IN SECTION D ARE 16' X 16' IN SIZE, WITH 4' X 8' DIVISIONS. THE LOTS IN SECTION E (ABOVE D) ARE 16' X 18' (FRONT X SIDE).

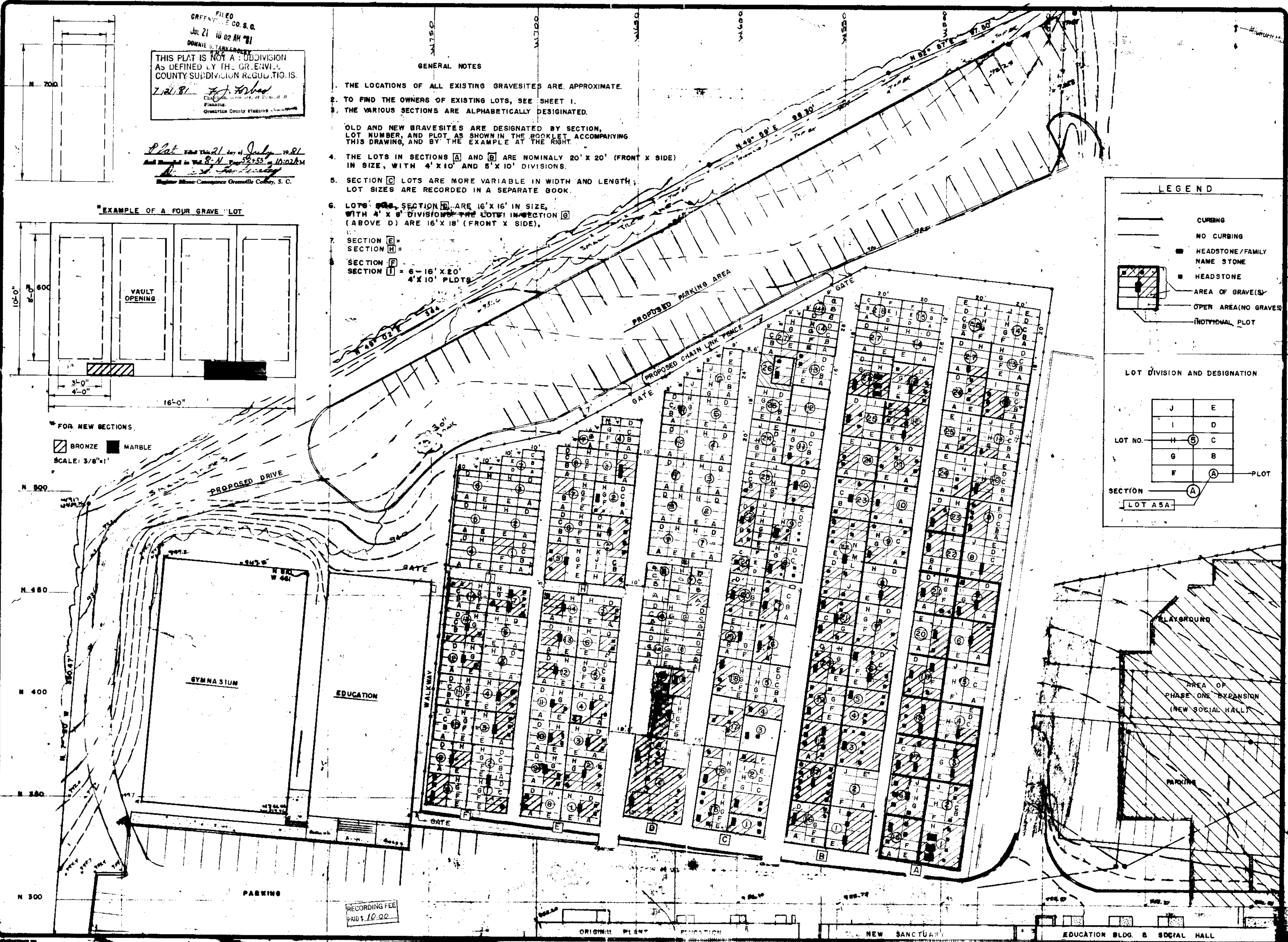
