of record.

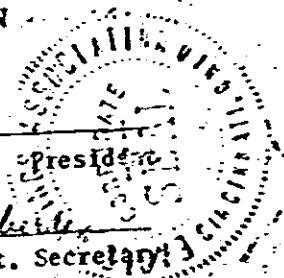
