(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seventy-Six Thousand Eight Hundred and no/100-----
DOLLARS (\$76,800.00) with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the eastern side of Ponders Road in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 4 on plat of Huntington, Sheet No. 5 prepared by Piedmont Engineers and Architects, dated March 4, 1968, recorded in Plat Book WW at Page 27 and being described, according to said plat, more particularly, to-wit:
