All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern

side of Huntington Road, being shown and designated as Lot No. 65 on a plat of HUNTINGTON WOODS, SHEET NO. 3, made by Piedmont Engineers and Architects, dated May 4, 1968, recorded in the RMC Office for Greenville County, S. C., in Plat Book WW, page 25 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Huntington Road at the joint front corners of Lots Nos. 64 and 65 and running thence along the common line of said lots, S. 18-02 E., 386.79 feet to an iron pin; thence N. 64-50 E., 180 feet to an iron pin at the joint rear corners of Lots Nos. 65 and 66; thence along the common line of said lots, N. 6-00 W. 344.77 feet to an iron pin on Huntington Road; thence along the southeastern side of Huntington Road, S. 80-50 W., 105.2 feet to an iron pin; thence continuing along said side of Huntington Road, S. 76-15 W., 147.5 feet to an iron pin, the point of beginning.
