WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain lot of land lying in the State of South Carolina, County of Greenville, on the eastern side of Seminole Drive, shown as Lot 47 on Plat No. 2 of Sunset Hills, recorded in the R.H.C. Office for Greenville County in Plat Book P at page 19 and being further described as follows:
