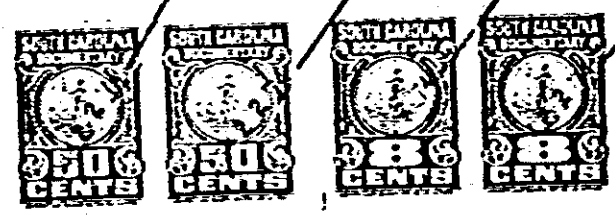
in the principal sum of Two Thousand Eight Hundred Eighty and No/100 Dollars (\$ 2,880.00) and,
