"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being near the City of Greenville, and being known and designated as Lots Nos. 6, 7, 8, 9 and 10 on plat of Lakewood Subdivision, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book Y at Pages 136 and 137, and having according to said plat, the following metes and bounds, to-wit:
