WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, situate on the Western side of a County Road (now known as Fowler Circle) being shown as Lots 16 and 18 on a plat of the property of E. M. Bishop and Rosa Lee Bishop, recorded in Plat Book S at page 127 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Fowler Circle, at the joint front corner of Lots 14 and 16 and running thence with the line of Lot 14, N. 87-30 W. 225.6 feet to a pin; thence S. 2 W. 199.6 feet to a pin at rear corner of Lot 20; thence with line of Lot 20, S. 87-30 E. 249.9 feet to a pin on the Western side of Fowler Circle; thence with the Western side of Fowler Circle, N. 2-34 W. 200 feet to the point of the beginning.
