SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifty Six thousand and No/100----- DOLLARS

(\$ 56,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Spring Hill Drive, in Austin Township, Greenville County, S. C., being shown and designated as Lot No. 76 on a plat of HOLLY TREE PLANTATION, PHASE I., made by Enwright Associates, Inc. dated May 28, 1973, recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-X, page 37, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Spring Hill Drive, joint front corner of Lots Nos. 76 and 77 and running thence with the curvature thereof to an iron pin on the western side of S.C. Highway 14, running thence with the western side of said Highway, N. 02-50-22 E. 160 feet to an iron pin, running thence S. 77-50-22 W. 100 feet to an iron pin, running thence S. 30-50-22 E. 127.06 feet to an iron pin at the joint rear corner of Lots Nos. 76 and 77, thence with the joint line of said lots S. 60-42-59 E. 126.26 feet to point of beginning.

This being the same property conveyed unto the Mortgagor herein by deed from Holly Tree Plantation of even date, to be recorded herewith.

This mortgage is equal in priority to that mortgage of Joe W. Hiller of even date over the above property in the original sum of \$8,250.00, being recorded herewith.
