WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Two Thousand Nine Hundred and No/100 ----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Northwest corner of Rogers Avenue and von Hollen Drive (Formerly King Street) near the City of Greenville, being shown as lot no. 14 on a plat of Perry Property, recorded in Plat Book I at Page 33 in the RMC Office for Greenville County, and described as follows:

BEGINNING at a stake at the Northwest corner of Rogers Avenue and von Hollen Drive (Formerly King Street), and running thence with the west side of said Drive, N 10-17 W 150 feet to a stake; thence S 79-28 W 50 feet to a stake at the corner of Lot no. 13; thence with the line of said lot S 10-17 E 170 feet to a stake on Rogers Avenue; thence with the Northern side of Rogers Avenue, N 79-28 E 50 feet to the beginning corner
