All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Holly Tree Lane, being shown and designated as Lot No. 56 on a plat of Holly Tree Plantation, Phase II, Section II, made by Piedmont Engineers & Architects, dated January 10, 1974, recorded in the R. M. C. Office for Greenville County in Plat Book 5-D at pages 47 and 48 and having the following metes and bounds, to-wit:
