All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township Lot 337, Botony Woods Section 7, RMC Office Greenville County Plat Book YY, at pages 76 and 77.
