-ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel and lot of land located in the City of Fountain Inn, Greenville County, State of South Carolina, and being shown on a plat for George Wenck prepared by John E. Woods, Registered Surveyor and dated October 5, 1971 and recorded in Plat Book 4-T at Page 76 in the R. M. C. Office for Greenville County and according to said plat, having the following metes and bounds:
