WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand Five Hundred Fifty Dollars and no/100-----DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the westerly side of Sugar Creek Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 43 on plat entitled "Map No.3, Section 1, Sugar Creek", as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-R, page 86, and having according to said plat the following netes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Sugar Creek Road, said pin being the joint front corner of Lot Nos. 42 and 43, and running thence with the common line of said lots N. 74-56-01 W. 217.08 feet to an iron pin, the joint rear corner of Lot Nos. 42 and 43; thence S. 16-29-25 W. 144.22 feet to an iron pin, the joint rear corner of Lot Nos. 43 and 44; thence with the common line of said lots S. 81-04-00 E. 228.39 feet to an iron pin on the westerly side of Sugar Creek Road; thence with the westerly side of Sugar Creek Road N. 12-00-00 E. 119.94 feet to an iron pin, the point of beginning.
