WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five Thousand Eight Hundred Fifty and No/100-----DOLLARS

(\$ 5,850.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

~~All that certain piece, parcel or lot of land, with all improvements thereon, as hereinafter described, to-wit: situate, lying and being in the State of South Carolina, County of Greenville, .....~~

All that piece, parcel or lot of land situate, lying and being on the Northern side of Shadowmere Drive, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 40 as shown on a plat entitled "Trollingwood, Section I", prepared by Enwright Associates, dated September 30, 1971, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at page 13 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Shadowmere Drive at the joint front corner of Lots Nos. 40 and 41 and running thence with the line of Lot No. 41 N. 19-11 W. 252 feet to an iron pin at the normal pool line of a lake known as Lake Trollingwood; thence with the normal pool line of said lake, S. 59-37 W. 177 feet to an iron pin at the joint rear corner of Lots Nos. 39 and 40; thence with the line of Lot No. 39 S. 24-00 E. 226.2 feet to an iron pin on the Northern side of Shadowmere Drive; thence with the Northern side of Shadowmere Drive N. 66-21 E. 94.9 feet to an iron pin; thence continuing with the Northern side of Shadowmere Drive N. 70-29 E. 60 feet to the point of beginning.
