NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot Number 11 Mill Creek Estate, as shown on plat of said subdivision recorded in Plat Book 4-X at Pages 87 and 88 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Hackamore Trail at the joint front corner of Lots 11 and 12 and running with said Trail, N 73-48 E 99.79 to an iron pin; thence continuing N 79-03 E 139.46 feet, S 70-57 E 50.0 feet and N 64-03 E 25.9 feet to an iron pin, joint corner of lots 11 and 10; thence turning and running with the common line of said lots, S 39-37 E 245.5 feet to an iron pin; thence turning and running S 76-17 W 382.0 feet to an iron pin, joint rear corner of lots 11 and 12; thence with the common line of said lots, N 20-42 W 247.0 feet to the point of beginning on Hackamore Trail.
