 WINFRED LISTER AND NANCY RUTH WADE
 (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten thousand and No/100

DOLLARS (\$10,000.00), with interest thereon from date at the rate of Five & Three-Fourths per centum per annum, said principal and interest to be repaid in monthly instalments of Seventy and No/100 Dollars (\$70.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about one mile north of Fairview Baptist Church, lying on the western side of Buncombe Road (State Highway # 415) and on the southern side of a new road, one-half of which was deeded by Robert E. Wade to Greenville County (a strip of 25 feet in width), and having the following courses and distances, to-wit:

BEGINNING on an iron pin at intersect of the margin of the said Highway # 415 and the new road, and runs thence with the western margin of Highway # 415, S. 75-30 E. 117 feet; thence S. 20-30 W. 216 feet; thence N. 66-37 W. 252 feet to iron pin on the eastern margin of new road; thence with the east margin of this road, N. 55-55 E. 235 feet to the point of beginning; and containing 0.86 of an acre, more or less.

Being the same premises conveyed to the mortgagors by deed of Robert E. Wade recorded in the RMC office for Greenville County in Book of Deeds 720 at Page 183.
