WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Five Thousand and 00/100-----DOLLARS

(\$ 35,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 123, Section 3, of Westcliffe, which plat was prepared by Piedmont Engineers & Architects on June 3, 1965, and revised September 24, 1965, said plat being recorded in the RMC Office for Greenville County in Plat Book JJJ-72, 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Coralvine Court at the joint front corner of Lots 123 and 124, and running thence with the common line of said lots, N. 43-56 E. 194 feet to a point in a creek; thence with the rear line of said lots, S. 32-04 E. 152.1 feet to an iron pin at the joint rear corner of Lots 114 and 123; thence with the line of Lots 114 and 123, S. 56-35 W. 175.9 feet to an iron pin at the joint front corner of Lots 114 and 123, said iron pin being on the northeasterly side of Coralvine Court; thence with the northeasterly side of Coralvine Court, N. 38-32 W. 110 feet to an iron pin, the point of beginning.

This being the same property conveyed to the Mortgagors herein by Deed of B. E. Huff, which Deed was recorded on January 9, 1978, in the RMC Office for Greenville County in Deed Book 1071-601.
