WHEREAS, I, Billy J. Johnson

(hereinafter referred to as Mortgagor) is well and truly indebted unto Fred E. Cartee

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fourteen thousand & no/100---

Dollars (\$ 14,000.00) due and payable in equal monthly installments of Three Hundred and Seven (\$307.90) & 90/100 Dollars, the first installment to be due and payable on October 1, 1980, and a like installment to be due and payable on the same day or each and every month thereafter until this indebtedness is paid in full, which will be five years with interest thereon from date at the rate of 11 1/2 per centum per annum, to be paid in installments as stated above

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying in Santt Township, on the northern side of a country surface graded road, known as the Blassingame Road, or the Jacobs Road, leading east from White Horse Road, being shown as the eastern one-half of Lot 4 on plat of property of Thomas A. Childress prepared by Pickell & Pickell dated July 1948, which plat is unrecorded and according to said plat has the following notes and bounds, to-wit:
