THIS MORTGAGE made this 23rd day of February, 1987, among Louie E. Cartee and Edith A. Cartee (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of Four Thousand, Two Hundred and No/100 (\$ 4,200.00), the final payment of which is due on March 1, 1987, together with interest thereon as provided in said Note, the complete provisions whereof are incorporated herein by reference;

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as lot #45, on the southern side of Mora Street, as shown on plat prepared for Leslie & Shaw, Inc., by C. C. Jones and Associates, February, 1957, recorded in the RMC Office for Greenville County in Plat Book NN, at Page 2, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Mora Street, the joint front corner of lots #45 and #44, and running thence along the line of these lots, S. 37-30 E. 125 feet to an iron pin; running thence S. 52-30 W. 65 feet to an iron pin at the joint rear corner of lots #45 and #46; running thence N. 37-30 W. 125 feet to an iron pin on the southern side of Mora Street; running thence along the southern side of Mora Street N. 52-30 E. 65 feet to an iron pin, point of beginning.
