THIS MORTGAGE made this 29th day of September, 1977
among Sam L. Brown (hereinafter referred to as Mortgagor) and FIRST
UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which
Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of
Seven Thousand, Two Hundred & No/100-- (\$ 7,200.00), the final payment of which
is due on October 15 19 87, together with interest thereon as
provided in said Note, the complete provisions whereof are incorporated herein by reference;

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in
hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys,
assigns and releases to Mortgagee, its successors and assigns, the following described premises located in
Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land in the State of South Carolina,
County of Greenville, being shown and designated as Lot Number 85, Section 3,
of Sheffield Forest, on plat made by Carolina Engineering and Surveying
Company, dated May 26, 1965, recorded in Plat Book III at Page 157 in the
RMC Office for Greenville County, and having, according to said plat, the
following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Confederate Circle, at
the joint front corner of Lots 85 and 86 and running thence with the common
line of said lots, N. 74-08 E. 197.3 feet; thence along the rear line of Lot
85, S. 30-15 E. 136.0 feet to a point; thence S. 75-0 W. 241.5 feet to an iron
pin on the Northeastern side of Confederate Circle, front corner of Lot 85;
thence with the Northeastern side of said Circle, N. 11-14 W. 128.5 feet to
the point of beginning.
