THIS MORTGAGE is made this 23rd day of August 1982, between the Mortgagor, John F. Heindel and Sondra J. Heindel (herein "Borrower"), and the Mortgagee, Security Federal Savings and Loan Association of Columbia, Columbia, S.C., a corporation organized and existing under the laws of the United States, whose address is 1233 Washington Street, Columbia, South Carolina, 29201 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-five Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 23, 1982 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2007.

ALL that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being on the southern side of Robinwood Drive in the Town of Simpsonville, Greenville County, South Carolina being known and designated as Lot No. 352 as shown on a plat entitled POINSETTIA SECTION 5 made by Piedmont Engineers and Architects dated July 19, 1974, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 5-P at Page 34 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Robinwood Drive at the joint front corner of lots nos. 340 and 352 and running thence S. 10-58 E. 142.66 feet to an iron pin; thence S. 41-00 W. 65.0 feet to an iron pin at the joint rear corner of lots nos. 351 and 352; thence along the common line of said lots, N. 48-49 W. 159.18 feet to an iron pin on the southerly side of Robinwood Drive; thence along the southerly side of Robinwood Drive, N. 46-14 E. 42.08 feet to an iron pin, N. 61-02 E. 108.91 feet to an iron pin and N. 75-58 E. 10.0 feet to an iron pin, the point of beginning.

To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
