THIS MORTGAGE is made this 27th day of March, 1981, between the Mortgagor, *Donald W. Arledge and Wanda P. Arledge* (herein "Borrower"), and the Mortgagee, *FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF HENDERSONVILLE*, a corporation organized and existing under the laws of *North Carolina*, whose address is *5th St. Church - Hendersonville, North Carolina 28733* (herein "Lender").
