## Warning Signs:

*How can you tell if your child is abusing drugs or alcohol?*

There is no single telltale pattern, experts say - especially since the teenage years often produce unpredictable behavior changes. There are, however, some tip-offs that your child may be struggling, including:

- Chronic eye redness, sore throat and/or dry cough.
- Chronic lying or unusual secrecy.
- Trouble in school or with the law, such as stealing.
- Deteriorating relationships with family and friends.
- Wild mood swings, hostility or abusive behavior.
- Chronic fatigue, withdrawal, carelessness about personal hygiene.
- Major changes in eating or sleeping patterns.
- Changes in grades, including increased grades due to misuse of stimulants.

## A Message From Greenville Family Partnership:

Dear Parents,

Red Ribbon Week provides parents, grandparents, and guardians with the opportunity to have a conversation about legal and illegal substance use with their children. Research shows parents have more influence on children than anyone else, especially in the formative years. The most valuable gift parents can give their children is their time. Parents and others should take the time to talk to their kids about the dangers of substance use and teachable moments are the best place to start!

Get to know your children; their friends; their friends' parents; and the world in which your children live. As children grow older, their friends can have more influence on their behavior and beliefs, especially in regards to substance use. But if parents and others lay the groundwork for prevention, their children will withstand the temptation of substance use. So, know the dangers of legal, illegal, and synthetic drug use so you can talk to your children about avoiding their negative consequences! Teach your children that avoiding substance use is the smartest decision that they will ever make!
